Hereby agrees to have an Academic Collaboration with each other in the following areas of mutual interest:

1. iTeach Schools will allow PCER-Panvel to place students as Training Interns for Internships as per their course requirement
2. Orientation Sessions for the B.Ed. students
3. Guest Lectures by iTeach School's eminent and distinguished staff members for the B.Ed. students
4. Visit to iTeach Schools
5. Campus Recruitment for the B.Ed. students (subject to selection)
6. Partnering in events (Annual fests, seminars, workshops) with mutual consent



Duration of the MoU:

1. This MoU is valid for a period of 2 academic years and will be renewed by mutual written agreement of both institutes at the end of this period.
2. Either institute shall have the right to terminate this MoU upon 60 days' prior written notice to the other institute.

Terms, Conditions & Confidentiality:








1. Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MOU.
2. Both parties agree to hold in confidence all information/data designated by the Institutes as being confidential which is obtained from either Institute or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other Institute.
3. The above confidential clause under this MoU excludes the information/data possessed by either Institute before entering into the MoU or independently developed and/or information already available through public domain.

Coordinators:

Both Institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.
