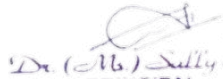

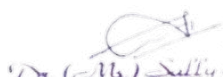

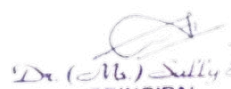

She also heard the incident from Mukundhan's perspective The other students who were a part of the internship group were also spoken to.
- There was no conclusive evidence to prove either of them right or wrong. But keeping in mind, Diksha's complaint and her feeling of being uncomfortable in the situation, the resolution proposed was to give Mukundhan a warning letter.
- A warning letter was issued to Mr. Mukundhan who said that he would be very careful in the future.
